Subject : **INCREASE IN FINES AND PENALTIES ON VIOLATORS OF SBMA RULES AND REGULATIONS ON MARINE CONSERVATION AREAS**

This certifies that:

The records of the Office of the Corporate Secretary show that during the Two Hundred Thirty - Second (232nd) Meeting of the Board of Directors of the Subic Bay Metropolitan Authority held last 25 January 2013 wherein there was a quorum to validly transact business, the following resolution was approved:

Resolution No. 13-01-4668

“RESOLVE, as it is hereby resolved, that upon recommendation of Management and without prejudice to COA Regulations and pertinent laws on the matter, the Board hereby approves the increase in fines and penalties on Violators of SBMA Rules and Regulations on Marine Conservation Areas, as follows:

A. Municipal Fishermen caught boat fishing inside the SBFZ secured waters:

First Offense	Fine of five thousand pesos (Php5,000.00) and confiscation of catch
Second Offense	Fine of ten thousand pesos (Php10,000.00) and confiscation of catch
Third Offense	Fine of fifteen thousand pesos (Php15,000.00) and confiscation of catch and fishing paraphernalia, including boat or vehicle

B. Municipal Fishermen or anybody caught using dynamite, cyanide or other toxic chemical, or illegal fishing technique inside the SBFZ secured waters:

Immediate impoundment of boat or vehicle, confiscation of fishing net and paraphernalia, fine of Fifty Thousand Pesos (Php50,000.00) and possible jail time.

Management’s Memorandum dated January 4, 2013 is incorporated herein by way of reference.”

SECOND OFFENSE: Fine of Five Thousand Pesos (Php5,000.00) and confiscation of catch	Fine of Ten Thousand Pesos (Php10,000.00) and confiscation of catch
THIRD OFFENSE: Fine of Ten Thousand Pesos (Php10,000.00) and confiscation of catch and Fishing paraphernalia, including boat.	Fine of Fifteen Thousand Pesos (Php15,000.00) and confiscation of catch and fishing paraphernalia, including boat or vehicle

Municipal fishermen or anybody caught using dynamite, cyanide or other toxic chemical, or illegal fishing technique inside the SBFZ secured waters:

FROM	TO
Immediate impoundment of boat or vehicle, Fine of Twenty Five Thousand Pesos (Php25,000.00) and possible jail time.	Immediate impoundment of boat or vehicle confiscation of fishing net and paraphernalia, Fine of Fifty Thousand Pesos (Php50,000.00) and possible jail time.
